2. COMPOSITION AND INFORMATION REGARDING THE INGREDIENTS

Ingredienti: AQUA (WATER/EAU), ALCOHOL DENAT., PARFUM (FRAGRANCE), POLYQUATERNIUM-37, BEHEN-TRIMONIUM CHLORIDE, SILICONE QUATERNIUM-22, DICAPRYLYL CARBONATE, PROPYLENE GLYCOL DI-CAPRYLATE/DICAPRATE, POLYGLYCERYL-3 CAPRATE, DIPROPYLENE GLYCOL, ISOPROPYL ALCOHOL, PPG-1 TRIDECETH-6, HEXAMETHYLINDANOPYRAN, COCAMIDOPROPYL BETAINE, PROPYLENE GLYCOL, BENZYL SALICYLATE, GERANIOL, CITRONELLOL, LINALOOL, ALPHA-ISOMETHYL IONONE, LINALYL ACE-TATE, HEXYL CINNAMAL, GLYCERIN, PALMITAMIDOPROPYLTRIMONIUM CHLORIDE, LAURYL GLUCOSIDE, BAMBUSA VULGARIS LEAF/STEM EXTRACT, CITRUS AURANTIUM PEEL OIL, LIMONENE, HYDROLYZED VE-GETABLE PROTEIN PG-PROPYL SILANETRIOL, PEG-8, ROSE KETONES, UNDARIA PINNATIFIDA EXTRACT, PANAX GINSENG ROOT EXTRACT, PEG-8/SMDI COPOLYMER, SODIUM POLYACRYLATE, PALMITOYL MY-RISTYL SERINATE.

3. IDENTIFICATION OF THE RISKS

It may irritate eyes (in case of contact).

4. FIRST AID INTERVENTION

First aid in case of

Contact with eyes: remove contact lenses if used, wash carefully and adequately with water; in the event of persistent irritation, please contact a doctor. **Contact with skin:** wash carefully with water. **Accidental ingestion:** consult a doctor. Do not induce vomit.

5. FIRE-PROOF MEASURES

Not inflammable products. In case of fire use nebulized water, chemical dust, carbon dioxide.

6. MEASURES IN THE EVENT OF ACCIDENTAL DISPERSION

Gather the product and wash with water. Don't pour back the product in the bottle. Don't use it.

7. HANDLING AND STORE UP

To keep in dry and well-aired places. Keep away from heating sources or temperature below 5°C.

8. PERSONAL PROTECTION/EXPOSITION CONTROL

The working environment should be well-aired, in case use mechanical air change (Attachment IV al DLgs 81/08). In case that employer indentifies risks not avoidable with other measures, it is compulsory to give to the workers suitable Individual Protection Systems (DPI) (Art. 75 del DLgs 81/08).

Normally stable at ambient temperature.

11. TOXICOLOGICAL INFORMATION
