2. COMPOSITION / INFORMATION ON COMPONENTS

The complete list of ingredients is shown on the packaging of the individual products in accordance with the provisions of Article 19 of Regulation (EC) 1223/2009.

3. HAZARDS IDENTIFICATION

When used according to the manufacturer's instructions, the product is safe for humans and the environment. The following information is relevant in case of misuse or accident.

The product can be flammable.

Contact of undiluted product with eyes can cause eye irritation.

Ingestion can cause irritation to the gastrointestinal tract.

May cause sensitization by skin contact.

It can cause an allergic reaction

It can cause skin irritation.

4. FIRST AID MEASURES

Measures in case of:

Involuntary contact with the eyes: remove any contact lenses, rinse immediately with plenty of warm water; if irritation persists, consult a doctor.

Involuntary ingestion: do not induce vomiting. Rinse mouth with water and then drink plenty of water. Consult a Poison Center or physician immediately.

Skin contact: wash skin immediately with soap and water. If skin irritation persists, consult a doctor.

5. FIRE FIGHTING MEASURES

In case of fire, use water spray, dry chemical, carbon dioxide.

6. ACCIDENTAL RELEASE MEASURES

Collect the leaked product with rags, convey into suitable containers for disposal according to the regulations. Wash contaminated areas with plenty of water. Never return the spilled product to the original container. Never reuse the spilled product.

7. HANDLING AND STORAGE

Handling

- · Carefully follow the instructions on the package and on the attached leaflet
- · Avoid any type of use not foreseen in the instructions.
- Avoid mixing with other products or similar products or with different substances not provided for in the specific instructions.
- · Use the product immediately and throw away any residues, without trying to reuse them.
- Do not use metal objects (containers, bowls, spatulas, brushes, combs) to mix and apply the product.
- Be careful when using a brush or comb, or during any massage to apply the product, not to scratch or irritate the scalp.
- · Keep the products out of the reach of children.

Storage

Store in dry and well ventilated places (room temperature). Do not store or use the product near open flames or sources of heat or electrical appliances or in direct sunlight. Do not store the product at temperatures below 5°C or above 40°C. Close the container tightly after the sensitivity test.

8. PERSONAL PROTECTION/ EXPOSURE CONTROL

The work environment must be adequately ventilated, possibly with mechanical air exchange. The points where emissions of vapors, gases or dusts, or spills of substances may occur, must be arranged in distinct areas, equipped with localized extraction systems or collection systems.
